In 2005, the brand was sold to Cadbury's, but Jo remains in an ambassadorial role, travelling the world as the brand grows internationally in countries including the US and Australia.

We are delighted to include **Susan Davis**, founder of Susan Davis International, a global public affairs and strategic communications company based in Washington D.C. to our speaker line up. Susan is also the Chair of Vital Voices Global Partnership, a nonprofit which grew out of the U.S. government's successful Vital Voices Democracy Initiative. The Vital Voices Democracy Initiative was established in 1997 by then-First Lady Hillary Rodham Clinton and former Secretary of State Madeleine Albright after the United Nations Fourth World Conference on Women in Beijing to promote the advancement of women as a U.S. foreign policy goal. As well as providing counsel to key industry and government executives worldwide on a day to day basis, Susan finds time to serve on several boards including Self Help Africa, U.S.; Medical Missions for Children; University College Dublin Graduate School of Business; Washington

Ireland Program Trustees Council; St. Judes Professional Board and the U.S.-Panama Business Council. Honors attributed to Susan include "Woman Business Advocate of the United States"; PRSA-NCC Hall of Fame; Asian Women of Influence Global Empowerment Award; Washington Business Journal's "Women Who Mean Business" and the Knights Templar prestigious Order of Merit.

Lara Morgan is the founder of Company Shortcuts and best selling Amazon author of "More Balls than Most", her story about building a global enterprise. Lara is a straight-talking entrepreneur who understands the frustrations felt by small and medium-sized businesses that have lost their way. Over seventeen years, Lara built her own international business, Pacific Direct, before selling a majority share 99% holding of the company for £20 million in 2008. She has mentored business leaders through frank and constructive feedback earning her a reputation as an inspirational and original public-speaker. Working hard as an advocate for the oft-forgotten medium sized business leaders Lara remains down-to earth and approachable.

Lara is also involved in advising further education leaders to ensure enterprise becomes a foundation part of the further education system. Lara also gives a great deal of time as ambassador for UKTI for export. Lara has been a finalist in Ernst and Young Entrepreneur 3 times and in 2005 she was a finalist in the Veuve Clicquot Businesswoman of the Year Award.

More than 470 women packed into the Ramada Hotel, Belfast, in November 2012, to celebrate the success of business leaders, entrepreneurs and senior managers at the only ceremony of its kind in Northern Ireland.

Roseann Kelly, Chief Executive of Women in Business NI, said: "Showcasing the best of what Northern Ireland business women have achieved in the past 12 months, these awards have grown in attendance by 25% on our inaugural awards last year. Such an increase in attendance proves to me how vitally important it is to celebrate and recognise those at the cutting edge of our economy, in what can only be described as the toughest of trading times in recent history."

The award for 'Outstanding Businesswoman of the Year' was

presented to Patricia Clements of Bradfor Ltd. There were some similarities between the career journeys of the winner and the event's guest speaker, 'Millionaire Entrepreneur' Michelle Mone OBE. Grainne Kelly of Bubblebum was awarded 'Best New Start Up'. Her motto in all that she does is 'whatever it takes, for as long as it takes' and she developed her innovative product from concept to shelf in nine months. Alyson Hogg of Vita Liberata was presented with the award for

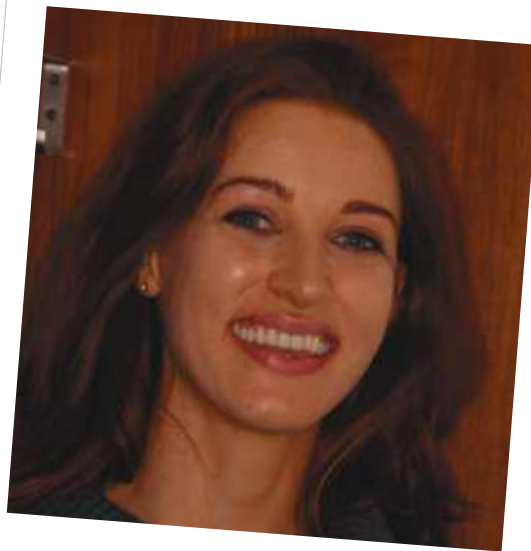

Translating EU proposals into Northern Ireland's boardrooms

Changes have been made to the EU's stance on introducing a quota system to ensure more women reach board level in leading organisations. Roseann Kelly of Women in Business NI looks at the implications for local women.

With news filtering through from the European Commission that they have taken action to break the glass ceiling, by aiming to attain a 40% objective of the under-represented sex in non-executive board-member positions, with the exception of small and medium enterprises, through legislation, I wonder how this could translate to boardrooms across Northern Ireland?

I'm not naively thinking that our government will push through similar legislation or that men will one day decide to step aside in order for females to take that step into the boardroom. However, for common sense, and our sons, as well as our daughters, steps need to be taken in order to change the current imbalance which exists across all industry sectors here.

Home Office figures show that women make up 51% of our population and they are the main consumer in the majority of households however currently women represent only 18.7% of non-executive directors in the largest publicly listed companies in the United Kingdom - and this figure has not changed drastically since 2003. Here in Northern Ireland we have one woman on the board of Invest Northern Ireland and, while I welcomed her appointment, the lone female appointment brought to the fore again the debate about quotas for board appointments.

In February 2012 David Cameron declared he would like to boost the number of women 'preferably without having quotas' and then stated that he would not rule them out 'if we cannot get there by other means'.

I have not met a business leader yet in favour of quotas, but the

Davies Report, which stated that companies had to voluntarily increase the proportion of women on their boards to 25% by 2015, or the government would take action to force them to do so, may seem, as we end 2012, a little on the ambitious side. The pace of change is too slow if we continue to grow the number of females on boards at the current rate and I'm not optimistic that, unless measures are taken, the target will be reached on time.

A recent European report rightly stated that female entrepreneurship is an 'economic' issue rather than a 'gender' issue and should be integrated into the business community's contributions as a whole.

Having more women in the workforce and increasing turnover can obviously help in working towards improving competitiveness and achieving more females in the boardroom. All EU member states have signed up to the Europe 2020 strategy which aims to raise the employment rate for adults to 75%.

However, research shows that women owned businesses invest more in training and approx two thirds aim to increase leadership capability of their managers than businesses in general.

Evidence from the USA shows return on investment from a similar programme where the number of female entrepreneurs doubled, creating new jobs and increasing the economic input.

The proportion of female entrepreneurs to male in the USA is 2:1 and this follows the

'Women's Business Ownership Act' of 1988. And whilst focusing on the development of female entrepreneurs, men should not be ignored; men should be included

in debate and communication and be encouraged to recognise the added benefits that female entrepreneurs can bring to the economy.

Another area of particular interest to me is the recommendation that academic studies that can lead to new business start-ups for women should be promoted. I've said before that I firmly believe that we need to encourage and teach our children in the area of business development from a young age to help the next generation reach their full potential.

And the recommendation of the creation of dedicated women's business centres is also intriguing – offering essential business information, networks, knowledge sharing, training and mentoring. At Women in Business NI we are already offering our members those essential elements for nurturing business growth and development.

The Retail Distribution Review

On 31 December 2012 the UK Financial Services Industry was subject to a major overhaul of its rules and regulations. This shakeup of the financial services world will touch every investor. The major changes go under the name of the Retail Distribution Review (RDR) but many people have no idea how this will affect them going forward.

A **Restricted** adviser will focus their advice on a limited or specific range of products or providers. Any adviser who does not meet the requirements to be Independent will be Restricted and must clearly explain what those restrictions are.

All advisers will be required to hold a higher minimum qualification they must also ensure that they act with integrity and treat customers fairly.
